

Retro Game Store “Backlit Modded GBA Console” Terms and conditions

1. Eligibility: This contest is open only to those who participate in the ‘Backlit Modded GBA Console’ promotion at the Retro Game Store Facebook Page <https://www.facebook.com/retrogamestoreau/> and who are 18 or older at the time of entry or have a parent or guardian’s permission. The contest is only open to legal residents of Australia and is void where prohibited by law. Employees of Retro Game Store, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the contest.
